4a (Code:) (Expenses \$ 689,364 including grants of \$ 102,276) (Revenue \$ 8,640) Education & Outreach- Education and Outreach: What Do You Wonder, a virtual program delivering direct STEM Education served 1,337 students & 76 teachers, with 264 hours of direct instruction. Spring into Action, also a virtual STEM program, served 721 students & 37 teachers with 68 hours of instruction. STAR Lab at the University of Arizona gives high school students access to professional research resources & mentorship. 35 students were directly impacted, with 25 mentors & 12 volunteers. The regional Science and Engineering Fair was held as a virtual program this year. SARSEF awarded more than \$97,000 in scholarships & prizes to students for high-quality research. This year, despite the extreme challenges of remote learning, 1,099 projects were entered. 70% of the participating students & 72% of Grand Awards winners came from a Title 1 school. Through SARSEF, 70 students and 12 teachers participated in the Arizona Junior Science and Humanities Symposium.

4b (Code:) (Expenses \$ 54,205 including grants of \$ 240) (Revenue \$) Racing the Sun - Racing the Sun is an opportunity for Arizona high school students to team up to design, build and race solar powered go-karts with the help of community mentors throughout the school year. During the 2020-2021 school year, 56 students participated in Racing the Sun with the help of community mentors and received 40 hours of direct support.

4c (Code:) (Expenses \$ 35,525 including grants of \$) (Revenue \$) Arizona STEM Adventure- AZ STEM Adventure provided 12 virtual and hands-on STEM activities over a one week period with 3 teacher professional development sessions, serving 1,800 students and 49 teachers. SARSEF built and distributed 1,670 kits and donated any extra supplies to teachers, parents, and schools, to serve another 1,160 students. Building the bags took roughly 20 volunteers and over 100 volunteer hours to complete. Bags were delivered by staff and volunteers with most schools located in Tucson and surrounding cities, but some longer routes took deliveries to Yuma, Phoenix, and San Carlos.
